



Limited Warranty

Jack-it, Inc. warrants that for a period of 1 year (from date of invoice) after a new part has been purchased from and installed by Jack-it, Inc., labor for said installation is guaranteed to be completed in accordance with manufacturer guidelines. Should vehicle and/or new components malfunction due to improper installation, Jack-it, Inc. will provide reasonable and necessary repair and pay for the cost of labor.

This warranty applies only to products purchased from and installed by Jack-it, Inc. Items supplied by the customer or any other person, business, or entity are NOT covered by Jack-it—customer assumes all liability for these items and their subsequent performance. Jack-it's liability is limited to the cost of labor to repair or replace defective or damaged parts that were purchased from Jack-it, Inc. Any and all incidental or consequential damages, including the cost of freight, are expressly excluded from this warranty. Should a part purchased from and installed by Jack-it, Inc. fail under normal use, Jack-it will perform the reasonable and necessary labor to repair the part free of charge for a period of 1 year from date of original invoice. However, parts and accessories are warranted by the manufacturer, not Jack-it, Inc. If the manufacturer refuses to provide a warranty for the defective item for any reason, the customer is responsible to pay for replacement parts. This warranty does NOT cover repairs or replacements made necessary by reason of negligence, alteration, accident or any use for which the parts installed were not designed or intended. All instructions given by Jack-it, Inc. on customer invoice must be strictly complied with or this warranty is void.

To have warranty work performed on your vehicle, you must bring your vehicle together with the original copy of your Jack-it, Inc. invoice to Jack-it, Inc. located at 1812 W. 3500 S. in West Valley City, Utah. Warranty is non-transferable and valid only for the customer whose name appears on the invoice/work order.
